



- Global X Canada (formerly Horizons ETFs) has seen its AUM grow nearly tenfold since its acquisition by Mirae Asset in 2011, recently surpassing CAD \$30 billion
- The firm offers one of the largest and most diverse suite of ETFs in Canada, ranging from thematic and leveraged & inverse ETFs to cash alternatives, providing investors with a variety of tools to adapt to changing market conditions

### United States



- Global X US, known for its differentiated lineup of thematic and income products, recently hit a milestone figure of \$50 billion in AUM
- Global X US has also shown a strong commitment to identifying innovative themes and delivering high-quality investment solutions to clients worldwide
- Of note, Mirae Asset newly established an AI business entity 'Wealthspot' in the US to lay the groundwork for the Group's future AI expansion

### United Kingdom and Europe



- Strengthening sales and trading to establish a presence as a global IB in the European market.
- Acquired GHCO, a European ETF market-making specialist, to expand its ETF market-making business in Europe.

### India



### China / Hong Kong SAR



- In 2003, Mirae Asset became the first domestic AMC to establish an overseas subsidiary with the founding of the Hong Kong office, marking a significant step forward in the Group's global expansion
- Notably, Mirae Asset was also the first domestic AMC to have ETFs included in the Stock Connect Scheme, a program that grants mainland Chinese investors access to high-quality products from the Hong Kong office
- By actively expanding its product lineup and increasing local sales personnel, the Hong Kong office aims to further penetrate the financial markets of mainland China

### Japan



- In 2019, Global X Japan was founded as a joint venture with Daiwa Securities Group
- Unlike traditional asset managers that focused on broad market products, Global X Japan garnered significant attention from local investors by providing differentiated offerings such as thematic and income ETFs
- As the only AMC in Japan specializing solely in ETFs, Global X Japan has experienced rapid growth since its inception to surpass \$2 billion in AUM

### Australia



- Stockspot, Australia's leading and most experienced online investment advisor, provides investors access to expert investment advice and portfolio management, helping them achieve their investment goals.
- Through Stockspot, we plan to integrate AI-strengthened capabilities and leverage synergies with Global X Australia to target both the Australian retail and superannuation markets.

- Adopts a strategic approach to revenue diversification by initially entering the asset management sector, followed by the securities industry.
- As the sole independent foreign-capital asset management company in India, Mirae Asset has focused on thorough localization, achieving rapid growth and expect to acquire Sharekhan, a local securities firm, thereby securing new growth opportunities
- Established an in-house index company to develop ETF indices and the firm is actively building a global ETF ecosystem, including liquidity provision and management.
